

## **[2022 Taitung Craft Design Award] Consent to Provide Personal Data**

- I. The objective for the Taitung County Government (hereinafter “the Organizer”) to obtain your personal data is to collect, process, and utilize your personal data for the execution of the relevant tasks, exhibition, and event planned by the organizer for the “2022 Craft Design Award” under the rules of the Personal Data Protection Act and the relevant laws and regulations, while following the privacy protection policy of the Organizer.
- II. You can provide the following personal data according to the requirements: Name, date of birth, National ID No., contact information, education, career, or other data that can be directly or indirectly used to identify yourself.
- III. You agree for the Organizer to confirm your identity and to contact you using the personal data you have provided, and to provide the information to the Organizer to carry out relevant services including various promotions, exhibitions, data statistics, and analysis, as well as other specific uses conforming to the stipulated businesses in the organizational rules of the Organizer, and for uses stipulated in other privacy protection policy regulations.
- IV. According to Article 3 of the Personal Data Protection Act, you shall be able to exercise the following rights regarding your personal data held by the Organizer:
  - (I) To make an inquiry and to review.
  - (II) To request a copy.
  - (III) To supplement or correct, provided that you shall provide adequate clarification according to the law.
  - (IV) To demand the cessation of the collection, processing, or use and deletion, provided that the Organizer can reject your demand according to the law if it is necessary for the practice of business.

However, if it:

- (I) Jeopardizes national security, diplomatic or classified military secrets, overall economic interests, or other significant national interests.
- (II) Obstructs government agencies and the Organizer to execute the statutory duties or required business.
- (III) Obstructs the significant interests of the organizer or a third party.

Then the Organizer may refuse.

- V. You can choose freely whether to provide your personal data to the Organizer or not; however, under conditions where the personal data provided by you was reported or found out by the Organizer to be insufficient to confirm the authenticity of your identity, or other

personal data was misused, misappropriated, or incorrect, the Organizer will then have the right to temporarily cease services provided to you.

- VI. The craft center will not be liable for the relevant compensation if craft center-related businesses caused a reduction in your rights and interests as a result of your practice of the aforementioned rights.
